## Update on Status of 67 Falun Gong Adherents Detained in Beijing (December 2007-March 2008)

1. The list is sorted by date of arrest from the most to least recent.
  2. Those individuals whose names are marked in rose have been sentenced to “re-education through labor camps”
  3. Where currently available, the Chinese spelling of the individual’s name has been included, particularly for those sentenced to RTL camps; the Center is in the process of finalizing research of the Chinese names of all those arrested; an updated list will soon be available on our website.

He works as a lawyer in a Beijing law firm, graduated from Nankai University in Tianjin. Police denied holding him, but on February 29, he called from station briefly, hired a lawyer, home searched without warrant on two occasions. Family reportedly filed a lawsuit against the Chaoyang Procuratorate for his illegal detention. Sentenced to 2.5 years RTL, transferred to Beijing Forced Labor Dispatch Center on April 2.
